Pupil Premium 2017-18

The School receives funding to help all children who are entitled to receive means tested Free School Meals or who are Looked After by the Local Authority. This funding is called Pupil Premium and will be used to help children to make good progress in School.

Inside this leaflet you will see how we plan to use this money to support individual children and groups of children. We will look at each child and consider which initiatives will help them as an individual.

Our aim is to support families in a variety of ways - these vary each year according to the needs of families.

We hope that you will be very pleased with the range of support available and that your child will benefit from this initiative.



Support within the School Curriculum

- Children in Year 6 will be targeted for any 1 : 1 tuition
- Children will be given extra reading support in class by staff or parent helpers.
- Children's Homework will be monitored closely to see if they need to be invited to attend Homework Club
- Children's progress will be closely monitored by their Class Teacher and Senior Staff.
- Children will be targeted for any special groups (e.g. Challenge Groups, Wave 2 and 3 support groups) where their Class Teacher feels they will benefit.
- Children's attendance will be closely monitored by Senior Staff and any problems will be discussed with Parents/Carers.

The School will prioritise children and their families to see if the support of any Wellbeing Service would be useful to them.

Support with Extra Clubs and Activities

Support for School Residential Holidays

- We will pay some of the cost of the Year 4 Trip
- We will pay some of the cost of the Year 6 Stubbers Trip
- Details will be confirmed each year. Parents must still complete the permission slip and return it to school.



Swimming

- We will pay the voluntary contribution for swimming. Parents must complete the permission slip and return it to school.

Support for Day Trips and Visits

- We will pay the full cost of all School Day Trips and Educational Visits - parents must complete the permission slip and return to School.



Free School Clubs

- We will pay for 1 free school club each term - parents can pick from the club timetable each term.
- We may run special clubs to which individual children are invited - these may be during the school day or at lunchtime and will be free.

Music Tuition

- We will offer free music lessons through Essex Music Services - currently guitar and keyboard lessons are provided during the school day.
- Other music lessons (e.g. violin through Woolmer Music Group) will be subsidized by us on an individual basis.



Do you Qualify?

Parents or guardians receiving the following benefits can claim Free School Meals.

- Income Support
- Jobseekers Allowance (Income Based)
- **Income related** Employment and Support Allowance
- Child Tax Credit with an annual taxable income of less than £16,190
- Pension Guarantee Credit
- Support under Part VI Immigration and Asylum Act 1999

You will not normally be eligible for Free School Meals if you receive any amount of Working Tax Credit.
